North Lanarkshire Council Chapelhall Revocation Order 2024 (Chapelhall AQMA Order)

Order revoking an Air Quality Management Area (AQMA)

Whereas North Lanarkshire Council ("the Council") having caused to be conducted a review and assessment of air quality in Chapelhall is satisfied that the air quality objectives in respect of the Particulate Matter (PM_{10}) and Nitrogen Dioxide (NO_2) annual mean objectives as specified in the Air Quality (Scotland) Regulations 2000 (as amended by the Air Quality (Scotland) Amendment Regulations 2002 and 2016) will be met in the area described in the Schedule below and shown outlined in red in the map attached hereto, for reasons of previous, current and projected compliance with the relevant air quality objectives.

The Council in exercise of the powers conferred on it by Section 83(2) of the Environment Act 1995 hereby makes the following Revocation Order for the Chapelhall AQMA designated in December 2024.

IT IS HEREBY ORDERED THAT:

- 1. The AQMA known as the Chapelhall AQMA designated for a breach/likely breach of the PM₁₀ and NO₂ annual mean objectives and as described in the Schedule below shall be revoked.
- 2. The Order shall be cited as the North Lanarkshire Council Chapelhall Air Quality Management Area Revocation Order 2024.
- 3. The Order shall come into force on Monday 9th December 2024.


Schedule to North Lanarkshire Council Chapelhall AQMA Revocation Order 2024

The designated area outlined in red on the attached map and known as the Chapelhall AQMA shall be revoked.

The designated area consists of the following locations:

- Beginning at road junction of Burniebrae Road and Carlisle Road.
- Boundary proceeds proceeds SE to rear of flatted dwellings at 51 Main Street.
- Boundary proceeds to rear of 53-69 Main Street before turning to SW to meet with Main Street
- Boundary continues SE along Main Street to some 50m along Bellside Road before returning along west side of Main Street.
- Boundary continues to front of 92, 78 and 70 Main Street before proceeding west along Roberton Street to meet with Lauchope Street.
- Boundary continues approx 100m along Lauchope Street then returns to western junction of Roberton Street and Lauchope Street.
- Boundary proceeds along Roberton Street contiuing north to rear of doctor's surgery at 30 Lauchope Street.
- Boundary dissects properties to rear of Queens Crescent and Main Street heading NE the NW between these properties.
- Boundary emerges at intersection between properties at 6 Bent Road and 12 and 14
 Main Street.
- Boundary then rejoins Carlisle Road between 12 and 14 Carlisle Road and continues NW some 100m along Carlisle Road.
- Boundary then returns along north side of Carlisle Road to original starting point at road junction of Burniebrae Road and Carlisle Road, Chapelhall.

The area contained within this boundary forms the proposed AQMA for Chapelhall.
