North Lanarkshire Council Coatbridge Revocation Order 2024 (Coatbridge AQMA Order)

Order revoking an Air Quality Management Area (AQMA)

Whereas North Lanarkshire Council ("the Council") having caused to be conducted a review and assessment of air quality in Coatbridge is satisfied that the air quality objectives in respect of the Particulate Matter (PM_{10}) and Nitrogen Dioxide (NO_2) annual mean objectives as specified in the Air Quality (Scotland) Regulations 2000 (as amended by the Air Quality (Scotland) Amendment Regulations 2002 and 2016) will be met in the area described in the Schedule below and shown shaded in brown on the map attached hereto, for reasons of previous, current and projected compliance with the relevant air quality objectives.

The Council in exercise of the powers conferred on it by Section 83(2) of the Environment Act 1995 hereby makes the following Revocation Order for the Coatbridge AQMA designated in December 2024.

IT IS HEREBY ORDERED THAT:

- 1. The AQMA known as the Coatbridge AQMA designated for a breach/likely breach of the PM₁₀ and NO₂ annual mean objectives and as described in the Schedule below shall be revoked.
- 2. The Order shall be cited as the North Lanarkshire Council Coatbridge Air Quality Management Area Revocation Order 2024.
- 3. The Order shall come into force on Monday 9th December 2024.

Schedule to North Lanarkshire Council Coatbridge AQMA Revocation Order 2024

The designated area shaded in brown on the attached map and known as the Coatbridge AQMA shall be revoked.


The designated area consists of the following locations:

- Beginning at east side of North Road, Coatbridge 50m north of roundabout/interchange between North Road and A8 to Edinburgh.
- Continue west across North Road for approx 50m then proceed NW to junction of Kirkshaws Road and entrance to Mayfield Place.
- Boundary runs on east side of entrance to Mayfield Place to intersection of Mayfield Place and property at No 5 Mayfield Place.
- Boundary proceeds NE for 50m to rear of Grange Hotel. Boundary then proceeds NNE through Grange Hotel car park and to rear of property at 256 Whifflet Street.
- Continuing NNW the boundary intersects to rear of properties at 246 to 254 Whifflet Street.
 Boundary continues in a NNW direction for approx 50m from western kerbside of Whifflet Street to rear of 244a and 244 Whifflet Street.
- Boundary follows same direction intersecting 240 Whifflet Street approx 10m from front facia of building.
- Boundary continues NNW approx 10m from front facia of 232 Whifflet Street and enters area to rear of 29 Margaret Street and proceeds between No 26 and 27 Margaret Street. Boundary continues to rear of flatted dwellings at 200 to 210 Whifflet Street, 188 to 198 Whifflet Street and 176 to 186 Whifflet Street. The boundary emerges to rear of 176 to 186 Whifflet Street adjacent to Hospital Street.
- Boundary continues between 2 to 8 and 10 to 16 Hospital Street. Boundary proceeds NNW to road (Meadow Street) between 1 to 7 and 2 to 4 Meadow Street. Boundary continues to rear of properties 148 Whifflet Road to School Street some 10m to west of property at No 1 School Road.
- Boundary continues SE to intersection of Coathill Street and School Road 10m west of Salvation Army Hall on School Road. Boundary proceeds NNW 10m to pick up point to east of Columba High School them NE across pick up area for 30m. The boundary then continues north approx 50m west of properties that form facia running north to south along Whifflet Street. The boundary proceeds across Hozier Street between 8 and 10 Hozier Street and to rear of 48, 50 and 52 Hozier Street.
- The boundary dissects the hall to rear of 38 to 44 Whifflet Street and continues north to the rear
 of the property at 448 Dundyvan Road where it continues SE for approx 50m before turning NW
 for a further approx 50m dissecting Dundyvan Road proceeding north some 50m from Whifflet
 Street across the railway line which underpasses Whifflet Road at the viaduct.
- The boundary continues north then NW some 20m to rear of property at 90 Whifflet Street. The boundary is expanded to some 50m west of roundabout at junction of Whifflet Street and

Coatbank Street and continues N, NE and NW approx 50m from west side of Coatbank Street to roundabout at junction of South Circular Road, Main Street and Coatbank Street – again the boundary is expanded some 50m to all sides of the roundabout and incorporates the properties at 1 to 5 South Circular Road and 144 to 166 Main Street.

- The boundary continues S, E and W from this roundabout following Coatbank Street, south. The boundary turns to SE dissecting properties at 33 Coatbank Street. Continuing south to the roundabout at the junction of Coatbank Street and Caldeen Road the boundary is expanded approx 50m to east of roundabout along Caldeen Road.
- The boundary then continues south adjacent to the east side of Whifflet Street and turns SE some 20m west of the western side of the community centre at Easton place. The boundary continues SE along Easton Place opposite Whifflet Station and proceeds south some 20m to the rear of the properties at 17 to 31 Easton Place and follows William Street to rear of Whifflet Court to junction of William Street and Calder Street. The boundary continues south between the properties at 18 and 20 Calder Street emerging at rear of the properties to continue SE along North Bute Road.
- The boundary proceeds SW at the corner of the property at 44 North Bute Road for some 60m before proceeding south and SE some 5 to 10m from the eastern side of Whifflet Street. The boundary dissects the area to the rear of the properties located at 159 to 165 Whifflet Street before heading SW at the corner of the properties at 167 to 169 Whifflet Street and continues to SE at rear of properties located at 171 to 173 Whifflet Street to 33 to 38 Clunie Place.
- The boundary continues to SW along area between Neidpath Place and Whifflet Street emerging and dissecting property at 207 Whifflet Street.
- Boundary expanded some 50m around roundabout at Whifflet Street, Hagmill Road, Kirkshaws Road and North Road (locally known as Shawhead roundabout).
- Boundary proceeds south to starting point at east side of North Road, Coatbridge 50m north of roundabout/interchange between North Road and A8 to Edinburgh.
- Beginning at the junction roundabout of the A725, Hagmill Road, North Road and Kirkshaws Road (Shawhead roundabout) the AQMA boundary follows Kirkshaws Road, westward for approx 0.8km.
- At Gullane Drive the boundary extends south for approx 50m to the north side of the A8 Glasgow and Edinburgh Road.
- The boundary then follows the north side of the A80 westward for approx 0.8km before heading north, just to the west oh Higherness Way for around 100m to meet with Kirkshaws Road again.
- The boundary then follows the southern side of Kirkshaws Road north, to meet with the junction of Old Monklands Road.
- The boundary then follows the north side of Kirkshaws Road eastward for approx 1.8km to rejoin the start of the AQMA boundary at Shawhead roundabout on the A725.
